<u>Power and Identity: Empirical and normative</u> <u>considerations of politics in divided societies.</u>

COURSE DESCRIPTION

In ethnically divided societies, the way in which sub-groups are defined has huge ramifications for politics. What does it mean to be in 'the Minority' or 'the Majority'? And how do our various understandings of those concepts determine various approaches to politics? This course will survey empirical and normative explorations of the politics of identity. In addition to the concept of ethnic 'identity' itself, we will explore empirical and normative approaches to the effect of power on identity itself, ethnic and religious violence, repression along identity lines, and group mobilization. Where possible, we will tie the literature to the German and American experiences.

WRITING ASSIGNMENTS

- Students are expected to complete a seminar paper (3500 4000 words), the topic for which will be developed in conjunction with the instructor.
- For parts 2-6 of the course, students are expected to compose short response essays (300-500 words per essay, 5 essays in total). In each response essay, students should outline a question or hypothesis that they feel has not been addressed by the literature and defend the intellectual value of that question or hypothesis. Ideally, the response essays will give students an opportunity to develop questions and ideas for the seminar paper.
